It is a condition of membership of the Club, that the Club, its office-bearers, committee persons, members and servants or agents are absolved for all liability howsoever arising for injury or damage howsoever caused (and whether fatal or otherwise) arising out of membership of this Club or participation in Scuba Diving, training to Scuba Dive, riding in any boat for or in connection with Scuba Diving or participating in any activity carried on by the Club, whether or not such injury or damage is in any way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of the Club, its office bearers, committee persons, members or servant or agents. Any person Scuba Diving, training to Scuba Dive, riding in any boat for or in connection with Scuba Diving or participating in any activity carried on by the Club is only allowed to do so on the distinct understanding that they do so entirely at their own risk.
